## Technical Statement

### Product Description

Homestead balustrades are ideal for customers wanting a strong, ready made aluminium balustrade solution for residential applications. Prefabricated panels are 1360mm wide x 975mm high and can be top mounted or face fixed with a newel post. A specially bracket is available for face fixing Homestead panels to waterproof or floating decks. Panels can also rack up to 35 degrees, which is popular for stairwells, and retaining walls or boundary fencing on slopes. Designed for NZ conditions, Homestead Balustrades have been engineered and tested to comply with the NZ Building Code and NZ standards AS/NZS1170 Occupancy A, A Other & C3. All Homestead balustrades are finished in a powder coat colour to client specifications.

### Scope of use

Juralco Homestead Balustrades is suitable for Domestic and Residential deck and balcony barriers, stairways, retaining walls or boundary fencing on slopes. NOT suitable for Commercial C3 applications or pool fencing.

Homestead Balustrade must only be installed in accordance with the Homestead product manual. Any deviation from standard fabrication or installation must be accompanied by a site specific PS1.
