## Technical Statement

### Product Description

The SUMNER Natural Stone Cladding System (SUMNER System) uses a fibre-cement board as the cladding substrate onto which is adhered a selected natural stone veneer. Sumner (fibre-cement) Board is fixed to timber or steel framing by way of 10g x 60mm stainless steel screws at 220mm centers applied around the perimeter and centre of the board. In order to ensure the board meets the durability requirements, the board is primed on the face. To prevent the ingress of moisture at vertical junctions, a specialized board tape is used, and for inter-storey junctions, the tape is used in place of z flashings.

### Scope of use

SUMNER is direct fix unless used as a cladding, in which case we supply our own proprietary cavity system (rigid backer and cavity battens).

- a) Up to 3 storeys, or 10m to top of chimney
- b) With floor plan area limited only by seismic and structural control joints, and
- c) External walls that are vertical, and roofs that are 60° or less above the horizontal, and
- d) Buildings that require specific design input must have framing stiffness equal to the framing provisions of NZS 3604, and Timber frame constructions complying with the NZBC, and Steel frame constructions must be to a specific design meeting the requirements of the NASH 3405, and Masonry constructions complying with NZS3604:2011, and Suitable for residential and commercial applications, in locations where the maximum wind zone is determined to be less than or equal to very high (50m/s).

## Installation requirements

The SUMNER System must only be installed on vertical surfaces in accordance with the Technical Literature. Wind Zone Suitable for locations where the maximum wind zone is determined to be less than or equal to very high (50m/s), or where specific design is employed. Where SUMNER Schist cladding system is to be used for High-wind zones a Rigid Air Barrier compliant with NZBC must be employed. SUMNER has also been appraised for weather tightness and structural wind loading when used for timber or steel framed buildings subject to specific design up to a design differential ultimate limit state (ULS) wind pressure of 2500Pa. Maximum Height Three stories buildings, and chimneys no higher than 10 meters above ground level.
